1 JOE: Frank and I had been looking for Johnsthon Benton for 2 the past year. During that time he'd taken approximately 37 thousand dollars from women in the Los Angeles Area. 3 4 His method of operation was to answer the ads in the 5 personal columns of the daily papers. He'd give the 6 woman a whirlwind courtship, then under the pretext of 7 having to clean up some business, before marriage, he'd 8 leave town. He'd call the next day and give them the 9 story about losing his wallet and identification. He'd 10 ask them for a hundred dollars. This in itself was to 11 throw off the suspicions of the victims. In the event 12 that they suspected that they were being taken in a 13 racket, a hundred dollars was small enough so that their 14 fears were quieted. Benton would answer about 20 to 30 15 of these adds at a time. And the requests for money 16 would hit all of the suspects at once. We'd had several 17 complaints lately and there was no way of knowing how 18 many women were being taken and were to embarrassed to 19 report it to the authorities. 4:30 P.M. We drove Miss 20 Terrance back to the city hall and had her check the 21 mugg books. She was unable to give us an identification 22 however. Another month passed. During that time we 23 received 14 more complaints. In all instances the 24 description of the suspect matched that of Johnathon Benton. All available sources of information were 25 26 checked. Bulletins had been gotten out carrying his

description and the name he used. No results.
