WELCOME to the National Lum & Abner Society's Tape Library! While a large number of the Lum and Abner radio broadcasts were never recorded... primarily during the 1931-34 and 1936-39 periods... this catalog contains every episode that is known to exist on tape or transcription disc. The dates have been determined by constant referral to the original scripts.

At this time, our shows are available as <u>cassettes only</u>, not reel-to-reel. Seeming gaps in the numbering system of the tapes exist in the event that more shows are discovered to fill in those gaps.

This is how the NLAS Tape Library operates: beside each tape number is a specification of the length of the cassette. (We use only 60- or 90-minute cassettes.) Select the tapes you wish; then, for each one, send a <u>blank</u> cassette of that same length, along with \$3.00 each, to the NLAS Executive Secretary:

We must ask that you limit your orders to five tapes at one time (at \$3.00 each, or \$15 total). Also, the tapes <u>must</u> be completely blank! Our tape duplicator does not erase as it copies, so if there is anything recorded on the tapes you send, our recordings will be dubbed on TOP of it. ALSO, because of the volume of orders we process, it would be very helpful if you <u>remove the plastic wrappers</u> that most commercially-sold cassettes come wrapped in!

A HINT: When buying blank cassettes to send, please try to choose good quality tapes. Do <u>not</u> pick the local discount store's 3-for-\$1.00 deal. The plain white cassettes available in bulk quantities from most electronics stores are fine.

The NLAS has attempted to ascertain that the shows in its Library are of the best sound quality possible. However, due to the age and varying sources for the recordings, some sound problems have cropped up from time to time. When these difficulties occur, they have been duly noted beside the date of that particular episode.

Until the dubbing process from the original 16-inch transcription discs was begun, very few Lum and Abner episodes survived with their opening and closing commercials intact. That is changing rapidly; refer to the particular section of the catalog to determine whether commercials are included or not.

(The following episodes are dubbed from original Horlick's Malted Milk discs. Except where noted, all contain their original opening and closing commercials. Dates given are for the original network broadcast; however, these discs were recorded for some sort of "bicycling" or syndication to individual radio stations on the Pacific Coast. Because they are made from inferior materials, a certain amount of scratchiness and surface noise will be noticeable.)

A. Fri., January 18, 1935 (Prog. 25)

L&A operate Pine Ridge Matrimonial Bureau; Squire wants to be a third partner.

B. Mon., January 21, 1935 (Prog. 26)

Matrimonial Bureau swamped by mail from all over the country; Lum will mail out photos of Abner to women who are looking for husbands.

C. Tues., January 22, 1935 (Prog. 27)

L&A read Matrimonial Bureau mail; how to stop someone from talking with his hands.

SIDE TWO

A. Wed., January 23, 1935 (Prog. 28)

Matrimonial Bureau will move into former Jot 'Em Down Store building; a girl, Hortense Kelly, falls in love with the photo of Abner she received.

B. Thurs., January 24, 1935 (Prog. 29)

Abner receives telegram from Hortense; she will arrive in Pine Ridge to meet him tomorrow.

C. Fri., January 25, 1935 (Prog. 30)

Abner goes to railroad depot to meet Hortense; doesn't know Lizabeth & Pearl are arriving on same train.

Abner in bed with two fake broken arms; Lum has an idea for a new business.

SIDE TWO

A. Fri., February 1, 1935 (Prog. 35)

L&A will finance reopening of Jot 'Em Down Store by selling aluminum pocket flashlights.

B. Mon., February 4, 1935 (Prog. 36)

William Horlick agrees to distribute L&A's flashlights as a premium for Horlick's Malted

SIDE ONE

A. Tues., February 5, 1935 (Prog. 37)

More mail for Matrimonial Bureau, but no orders for flashlight have come in yet.

B. Wed., February 6, 1935 (Prog. 38)

L&A will have election for president of Jot 'Em Down Store; Lizabeth files insurance claim on Abner's fake broken arms.

C. Thurs., February 7, 1935 (Prog. 39)

Lum tells listeners on party line that Abner's broken arms are phony; Lizabeth also hears Lum's announcement.

SIDE TWO

A. Fri., February 8, 1935 (Prog. 40)

Insurance company pays Abner \$200.00; Lum will break into Abner's house tonight and steal check to keep Lizabeth from cashing it.

B. Mon., February 11, 1935 (Prog. 41)

Lum is very nervous, as everyone in Pine Ridge is looking for the person who broke into Abner's house.

C. Tues., February 12, 1935 (Prog. 42)

Lum arrested and thrown in jail; Pine Ridge citizens force him to resign as president of school board.

L&A inspect their rolling store; the question is, how to get it <u>out</u> of the blacksmith shop?

C. Fri., Aug. 16, 1935 (Prog. 175)

Abner gets rolling grocery out of blacksmith shop the hard way.

SIDE TWO

A. Mon., Aug. 19, 1935 (Prog. 176)

Cedric loads merchandise into rolling store; back of store is heavier than the front. B. Tues., Aug. 20, 1935 (Prog. 177)

Squire goes to Arizona to sell silver mine; more delays in opening rolling store.

L&A decide to sell silver mine; Dick Huddleston has news about their prospective buyer.

A. Fri., Aug. 30, 1935 (Prog. 185)

Stockholders meet again; vote to run Squire out of town and send lynch mob after Lum.
