FALL CONVENTION GOES TO PURDUE

A MAJORITY OF THOSE VOTING FOR THE FALL CONVENTION SITE DESIGNATED PURDUE UNIVERSITY AS THEIR CHOICE. SO THE FALL CONVENTION WILL SE HELD ON PURDUE UNIVERSITY CAMPUS, SEPTEMBER 5 AND 6. THAT MEANS GIB WILLIAMS CAN GET TO WORK NOW.

PRESIDENT INGHAM #ILL ANNOUNCE A CONVENTION PROGRAM COMMITTEE WITHIN A FEW DAYS, AND YOU'LL BE KEPT ADVISED ON PLANS. ONE PLAN YOU CAN MAKE IS TO BE PRESENT AT THE MEETING. PLAN TO BRING A NUMBER OF YOUR STAFF MEMBERS. ILLINOIS WILL CHALLENGE YOU ON THE NUMBER, WHAT SAY?

WISCONSIN LEGISLATURE AGAIN SMILES ON WHA

ON JUNE 4 THE WISCONSIN LEGISLATURE PASSED THE SECOND BILL TO EXTEND AND IMPROVE THE BROADCAST SERVICE OF STATE-STATION WHA. THE BILL PROVIDED FUNDS FOR THE PURCHASE OF LAND, CONSTRUCTION OF A STATION HOUSE AND THE ERECTION OF A MODERN ANTENNA. THE FIRST BILL NEARLY DOUBLED THE STATION'S OPERATING BUDGET.

THE WHA PLAN IS TO MOVE THE TRANSMITTER TO A SITE SOME FIFTEEN MILES FROM MADISON IN THE DIRECTION OF THE STATE'S CENTER OF POPULATION. THIS CHANGE, COUPLED WITH THE IMPROVED TRANSMISSION GIVEN BY THE TALLER RADIATOR, WILL BRING POPULOUS MILWAUKEE COUNTY WITHIN THE PRIMARY SERVICE RANGE OF THE STATION. OVER HALF OF THE POPULATION OF THE STATE WILL THUS BE WITHIN THE PRIMARY SERVICE AREA OF THE TRANSMITTER.

SMILES FOR HIGGY AND OHIO STATE, TOO

R. C. HIGGY, DIRECTOR OF WOSU, WRITES:

"YOU CAN SAY FOR US ANYTIME NOW THAT WE HAVE NEW STUDIOS AND OFFICES IN THE MAKING AS THEY ARE DEFINITELY UNDERWAY NOW. THE UNIVERSITY ARCHITECT IS NOW DRAWING PLANS AND THE MONEY IS ALL SET ASIDE FOR AN ADDITION TO OUR JOURNALISM BUILDING WHICH WILL GIVE US COMPLETE NEW STUDIOS AND OFFICES DONE IN A VERY SUBSTANTIAL WAY. I DON'T KNOW JUST HOW WE WILL STAND IT ALL AFTER LIVING FOR TWENTY YEARS IN WALLBOARD TEMPORARY STUDIOS AND OFFICES."

"THANK YOU FOR YOUR LETTER AND THE SUGGESTION THAT TRANSCRIPTIONS OF THE "SPEAKING OF LIBERTY" SERIES BE MADE AVAILABLE FOR NON-COMMERCIAL RADIO STATIONS. WE HAVE DISCUSSED DISTRIBUTING RECORDINGS, BUT THE EXPENSE, AS YOU KNOW, IS RATHER HIGH, AND MUCH AS WE WOULD LIKE TO DO SO, I'M NOT SURE THAT OUR BUDGET WILL PERMIT IT. I WILL HOWEVER TAKE THE MATTER UP WITH THE COUNCIL EXECUTIVES AND SEND YOU WORD A LITTLE LATER ABOUT OUR DECISION."

NEW FM STATION FOR SAN DIEGO

THE SAN DIEGO (CALIFORNIA) UNIFIED SCHOOL DISTRICT HAS BEEN GRANTED A CONSTRUCTION PERMIT BY THE FEDERAL COMMUNICATIONS COMMISSION FOR A NON-COMMERCIAL EDUCATIONAL BROADCAST STATION TO SERVE 55 EDUCATIONAL UNITS IN THAT AREA. IT IS AUTHORIZED TO OPERATE ON 42,300 KILOCYCLES, WITH I KILOWATT OF POWER, EMPLOYING FREQUENCY MODULATION (FM).

THE SAN DIEGO SCHOOL SYSTEM INTENDS TO UTILIZE THIS SERVICE TO ADVANCE ITS EDUCATIONAL PROGRAM BY REBROADCASTING TO SPECIFIC CLASSES OR SCHOOLS RECORDED TALKS, PLAYS, MUSICAL PROGRAMS AND EVENTS OF AN EDUCATIONAL OR HISTORIC NATURE, PROVIDE THE VARIOUS SCHOOLS WITH TALKS, PLAYS, MUSICAL PROGRAMS, AND OTHER SPECIAL ACTIVITIES AS PRESENTED BY CLASSES IN THE SCHOOL SYSTEM, AND, INCIDENTALLY, TO TRAIN STUDENTS IN THE FIELD OF RADIO COMMUNICATION.

THE COST OF THE SYSTEM IS ESTIMATED AT SLIGHTLY MORE THAN \$6,000. IT IS PROPOSED TO LOCATE THE TRANSMITTER AT 348 WEST MARKET STREET, SAN DIEGO.

KWLC, LUTHER COLLEGE, WAS GIVEN PERMISSION TO OPERATE SPECIAL PERIODS IN ORDER TO BROADCAST LUTHER COLLEGE SUMMER SESSION CONVOCATIONS. (6/16/41)

WNAD, UNIVERSITY OF OKLAHOMA, WAS GRANTED AUTHORITY TO REMAIN SILENT FROM AUGUST 1 TO SEPTEMBER 14 IN ORDER TO OBSERVE SUMMER VACATION. (6/16/41)

KFDY, SOUTH DAKOTA STATE COLLEGE, WAS GRANTED PERMISSION TO REMAIN SILENT FROM JUNE 15 TO SEPTEMBER 15. (6/18/41)

WBAA, PURDUE UNIVERSITY, WAS GRANTED EXTENSION OF COMPLETION DATE ON ITS CONSTRUCTION PERMIT WHICH CALLS FOR NEW TRANSMITTER, NEW SITE, AND INCREASE IN POWER, AND CHANGE IN HOURS OF OPERATION. (6/19/41)

MUNICIPAL BROADCASTING SYSTEM, CITY OF NEW YORK, WAS GRANTED ITS APPLICATION FOR A CONSTRUCTION PERMIT ON 43,500 KC IN LIEU OF 46,700. (6/23/41).

THE COMMISSION EN BANC ON MAY 27 AMENDED ITS RULES OF PRACTICE AND PROCEDURE BY STRIKING THE THIRD PROVISO OF SECTION 1.71 THEREOF, READING AS FOLLOWS:

"PROVIDED, FURTH©R, THAT IN CASES WHERE AN APPLICANT DESIRES A MODI-FICATION OF A RULE OR REGULATION, HE SHALL SUBMIT A FORMAL PETITION SETTING FORTH THE DESIRED CHANGE AND THE REASONS IN SUPPORT THEREOF."

THE RULES OF PRACTICE AND PROCEDURE ARE AMENDED BY ADDING THE FOLLOWING NEW PROVISION:

"AMENDMENT OF RULES"

"Sec. 1.81 - Requests for amendment of rules. Any rerson may petition for amendment of any rule or regulation. Such petition shall show the desired change in the rules and regulations and set forth the reasons in support thereof.

Paragraph (B) of Section 1.72 of the Rules of Practice and Procedure is hereby repealed, and the following provisions adopted in Lieu thereof:

- (8) IF AN APPLICANT IS REQUESTED BY THE COMMISSION TO FILE ANY DOCU-MENTS OR INFORMATION NOT INCLUDED IN THE PRESCRIBED APPLICATION FORM, A FAILURE TO COMPLY WITH SUCH REQUEST WILL CONSTITUTE A DEFECT IN THE APPLICATION.
- (C) APPLICATIONS WHICH ARE NOT IN ACCORDANCE WITH THE COMMISSION'S RULES, REGULATIONS OR OTHER REQUIREMENTS WILL BE CONSIDERED DEFECTIVE UNLESS ACCOMPANIED EITHER (1) BY A PETITION IN ACCORDANCE WITH SECTION 1.81

TO AMEND ANY RULE OR REGULATION WITH WHICH THE APPLICATION IS IN CON-FLICT, OR (2) BY A REQUEST OF THE APPLICANT FOR WAIVER OF, OR AN EX-CEPTION TO, ANY RULE, REGULATION OR REQUIREMENT WITH WHICH THE APPLI-CATION IS IN CONFLICT. Such REQUEST SHALL SHOW THE NATURE OF THE WAIVER OR EXCEPTION DESIRED AND SET FORTH THE REASONS IN SUPPORT THEREOF.

(D) DEFECTIVE APPLICATIONS WILL NOT BE CONSIDERED BY THE COMMISSION."
