#### NAEB PLEIDGES AID IN WAR!

ON THE DAY THAT JAPAN BOMBED UNITED STATES POSSE SIONS, THE FOLLOWING TELEGRAM WAS SENT TO PRESIDENT ROOSEVELT ON BEHALF OF NAEB:

"IN THE PRESENT EMERGENCY OUR EDUCATIONAL RADIO STATION REAFFIRM THEIR FAITH IN DEMOCRACY, PLEDGE THEIR FACILITIES TO SERVE OUR COUNTRY AND AWAIT THE ORDERS OF OUR COMMANDER-IN-CHIEF."

#### FALL CONVENTION TO WISCONSIN

NAEB MEMBERS, MEETING IN CONVUNCTION WITH THE FIFTH SCHOOL BROAD-CAST CONFERENCE IN CHICAGO ON DECEMBER 4, VOTED TO APPROVE THE MAIL VOTES OF THE NAEB MEMBERS, ELECTING TO MEET AT MADISON, WISCONSIN NEST FALL. #### WNYC AND DEFENSE

HERE IS A SUMMARY OF SOME OF THE ACTIVITIES OF WNYC, NEW YORK CITY'S OWN STATION, DURING THE TWO DAYS, (SUNDAY AND MONDAY, DECEMBER 7 AND 8.

SUNDAY, DECEMBER 7, PUT ON THE FIRST RADIO ANNOUNCEMENT OF THE RAID ON HAWAII. (EXACT TIME 2:25:15 p.m.) THANKS TO THE ASSOCIATED PRESS AND THE FACT THAT WE WERE IN THE MIDDLE OF A NEWS REPORT PERIOD. PRESENTED SUMMARIES OF THE LATEST NEWS AT 3:00 p.m., 3:30 p.m., 4:00 p.m., 4:15 p.m., 5:00 p.m. AND EVERY HALF HOUR AFTER THAT AT 20 MINUTES AFTER THE HOUR AND TEN MINUTES BEFORE THE HOUR. REMAINED ON THE AIR UNTIL MIDNIGHT TO BRING BULLETINS AND SPECAUL ANNOUNCEMENTS. WHYC'S REGULAR SIGN OFF TIME IS 5:30 p.m. BROADCAST THE MAYOR'S SPEECH DIRECT FROM CITY HALL, EXCLUSIVELY AT 5:15 p.m. AND FED IT TO NBC, MUTUAL AND WHN AT 6:00 p.M.

MADE THE FOLLOWING SMECIAL ANNOUNCEMENTS DURING THE COURSE OF THE EVENING:

(1) ALL NAVAL PERSONNEL TO REPORT FOR DUTY AT ONCE.

(2) ALL PERSONNEL OF MITCHELL FIELD TO REPORT AT ONCE.
(3) ALL PERSONNEL OF FLOYD BENNETT FIELD TO REPORT AT ONCE.

(4) NAVAL RECRUITING OFFICES TO OPEN AT 8:00 A.M.
(5) MARINE RECRUITING OFFICE TO OPEN AT 7:30 A.M.

(6) AIR RAID WORDENS AND MEMBERS OF THE FIRE DEPARTMENT AUXILIARY COPRS TO STAY NEAR TELEPHONES IN CASE OF EMERGENCY CALLS.

(7) TRANSPORTATION FACILITIES NOW AVAILABLE FOR MEN FROM MITCHELL FIELD AT PENNSYLVAIN IA STATION. ACTED AS A CLEARING HOUR, PASSING ANNOUNCEMENTS TO RADIO STATIONS THROUGHOUT THE CITY.

MONDAY, DECEMBER 8, News SUMMARIES EVERY HOUR ON THE HOUR, WITH NEWS BULLETINS INSERTED INTO PROGRAMS WHENEVER WARRANTED. BROADCAST THE PRESIDENT'S SPEECH AT 12:30 p.m. REBROADCAST THE PRESIDENT'S SPEECH AT 4:15 p.m. ARRANGED FOR SOUND TRUCK TO CARRY THE BROADCAST AND AMPLIFY THE SPEECH TO CROWDS AT CITY HALL PLAZA. SOUND TRUCK TAKES RECORDING UP TO TIMES SQUARE AND PLAYS IT FOR CROWD AT 2:30 p.m. SOUND TRUCK AMPLIFIES REBROADCAST FOR CROWD AT SUB-TREASURY BUILDING AT 4:15 p.m. BROADCAST THE FOLLOWING SPECIAL ANNOUNCEMENTS:

(2) GENERAL PHILIPSON ANNOUNCES NO CURTAILMEN OF MILITARY LEAVES AND FURLOUGHS.

(3) NAVY RECRUITING ANNOUNCEMENTS, ARMY AIR CORPS ANNOUNCE-MENTS AND MARINE RECRUITING ANNOUNCEMENTS.

(4) SPECIAL ANNOUNCEMENT FRO COLONEL MEDERMOTT RE SELECTIVE SERVICE INDUCTEES AND THEIR ELEGIBILITY FOR ENLISTMENT IN THE ARMED FORCES.

(5) SPECIAL ANNOUNCEMENT FROM MARKETS COMMISSIONER WILLAUM FELLOWES MORGAN, JR. WARNING AGAINST FOOD HOARDING.

(6) AIR RAID WARDENS AND FIRE DEPARTMENT AUXILIARY CORPS
MEMBERS TO KEEP IN TOUCH WITH TELEPHONES FOR ANNOUNCEMENTS OF SPECIAL DRILLS.

AGAIN ACTED AS CLEARING HOUSE FOR THESE ANNOUNCEMENTS, CALLING THEM TO OTHER RADIO STATIONS THROUGHOUT THE CITY TO ASSURE COMPLETE COVERAGE.

#### FLY COMMENTS ON RADIO CENSORSHIP

CHAIRMAN JAMES LAWRENCE FLY OF THE FEDERAL COMMUNICATIONS COMMISSION TOLD HIS PRESS CONFERENCE ON DECEMBER 15 NITHER THE COMMISSION NOR THE DEFENSE COMMUNICATIONS BOARD WAS CONCERNED WITH CENSORSHIP OF RADIO AND PRESS SERVICES. FLY SAID IF THERE WAS ANY CENSORSHIP, IT WOULD BE BY SOME OTHER AGENCY OF THE GOVERNMENT.

HOW WELL WE KNOW THAT! THE FOLLOWING LETTER REGARDING THE RADIO SERIES OF THISTITLE IS FROM FRANK K. TELFORD, RADIO SECTION, OFFICE OF EMERGENCY MANAGEMENT:

"YOU CAN'T DO BUSINESS WITH HITLER," IS A TRANSCRIPTION SERIES, WRITTEN AND PRODUCED BY THIS OFFICE. WE EXPECTED TO RELEASE IT TO ALL LOCAL STATION REQUESTING IT WITHIN THE NEXT FEW WEEKS.

"THE ASIS' DECLARATION OF WAR, HOWEVER, HAS NECESSITATED CERTAIN READJUSTMENTS RELATING TO THIS SERIES. OUR RELEASE DATE HAS BEEN SET INDEFINITELY FORWARD.

"WE APPRECIATE YOUR INTEREST AND IF AND WHEN THIS SERIES IS RELEASED WE SHALL NOTIFY YOU."

### DOPE ON NEW YORK FM STATIONS -- NOVIK, WNYC, SPEAKING:

"The dismissal of the petition for rehearing and other relief directed against us by Station WDRC in Harford was to get us to change the Original grant by the F.C.C. of 43.5 Megacycles to 43.9 Megacycles. The F.C.C. then issued us a modified construction permit to permit us to erect a new FM station, W39Ny, hter in New York in the Commerchal Band.
